



## TRANSPORTATION NOTICE PUBLIC INFORMATION MEETING FOR ELY ROADWAY RECONSTRUCTION PROJECT

**PURPOSE OF MEETING:** The Nevada Department of Transportation (NDOT), in cooperation with the City of Ely, invites you to attend a public information meeting to provide an update and encourage input from the community for the Roadway Reconstruction Project in Ely, Nevada. Project elements include roadway reconstruction, lane reconfiguration, drainage and utilities improvements, traffic signal improvements, lighting and aesthetics features, and pedestrian safety enhancements.

**PROJECT BENEFITS:** The purpose of the project is to improve roadway conditions throughout the project area, alleviate flooding during storm events, upgrade water and sewer facilities, and enable safe access for all roadway users.

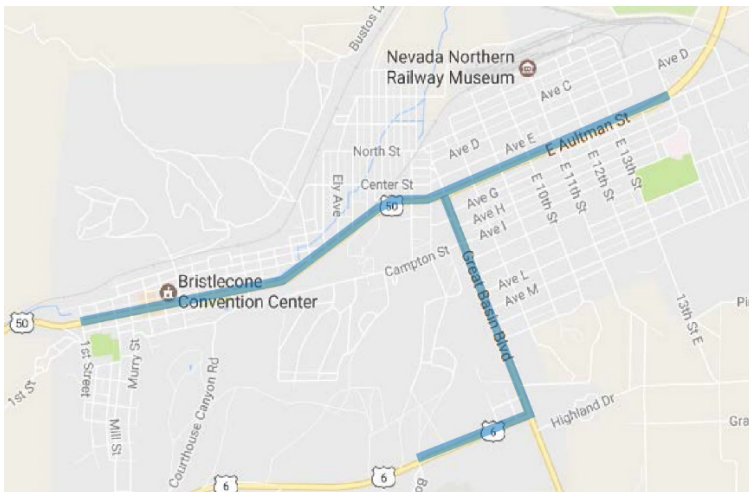

Specific work elements include – within the city limits (see map):

Roadway redesign using complete streets concepts, including:

- Roadway reconstruction
- Lane reconfiguration
- Americans with Disabilities Act (ADA)/sidewalk/curb and gutter improvements
- Lighting improvements
- Addition of several flashing beacon pedestrian crossings
- Aesthetics
- Drainage improvements
- Sections of water and sewer pipeline replacement, in coordination with the City
- Fiber optic installation
- Traffic signal improvements
